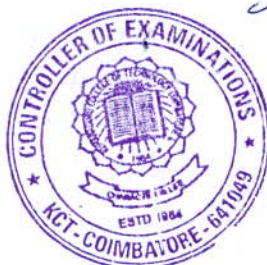


**RESOLVED FURTHER THAT** the following conditions be followed towards the conduct of the examination:-

- 1) A special fee of Rs.5000/- shall be collected from the students along with normal examination fee, as prescribed by the University, for each paper (as approved earlier in the Syn. Res.No.241.20).
- 2) Examination be conducted in offline / online mode depending on the COVID-19 pandemic situation.
- 3) The O/o the Controller of Examinations / Additional Controller of Examinations (UD), Anna University and the O/o the Controller of Examinations of Autonomous Colleges have to provide facilities for the students' registration of subjects and mode of payment through online etc. for the smooth conduct of examination.
- 4) Examinations be conducted only for registered subjects - that are received by the office of the Controller of Examinations / Additional Controller of Examinations (UD), Anna University and the O/o the Controller of Examinations of Autonomous Colleges - on or before the schedule dates.
- 5) Based on the registration of subjects, the schedule of examination will be announced later.
- 6) **No further chance to appear in the examination will be given to the students in this category.**

I request you to publish all the instructions in connection with this examination in the official website of the Controller of Examinations of your college, as this is the last opportunity for these students.

In this context, you are requested to follow the recommendations relevant to the Autonomous Colleges and to conduct the examinations for the students of your College, who have exhausted the permitted maximum period (as per their respective Regulations), during August 2021, February 2022 and August 2022. Further, the students may be advised to utilize these three chances with utmost care and diligence, since this is the final and last chance provided by the University.
