This has reference to your application I.D. No. 5516-09/04/2021 seeking accreditation by National Board of Accreditation to the UG Engineering program in Tier-I and PG Engineering program applied by Kumaraguru College of Technology, Chhinnavedampatti, Coimbatore- 641 049, Tamil Nadu.

2. An Expert Team conducted onsite evaluation of the programs from 19th to 21st May, 2023. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In case of the UG Engineering program which have been granted full accreditation for 6 years under Tier I January 2016 Document, the program should be applied in Tier I Second Cycle February 2021 SAR document at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Kumaraguru College of Technology, Chhinnavedampatti, Coimbatore- 641 049, Tamil Nadu as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
